Merz Aesthetics Privacy Policy

Merz Aesthetics (or "us", "we" and "our") values privacy and is committed to sharing how Merz Aesthetics collects, uses, shares, secures and retains/deletes your personal information. This Privacy Policy describes how a company/entity of Merz Aesthetics located within the Asia Pacific region ("Region") handles personal information, what data we collect, why we collect it, and with whom we share it.

Responsibility

Merz Aesthetics takes responsibility for processing personal information about you that is collected or otherwise used as you use this website ("Site") or in services provided by Merz Aesthetics in the process of conducting general business ("Services"). Trust is an important Merz Aesthetics value, and we aim to earn your trust not just by providing safe, effective pharmaceuticals and medical devices but also by responsibly managing your personal information.

Why We Process Personal Information

Like most companies, we process your personal information for legitimate and lawful reasons related to providing our goods and services to you. We describe the data we process and the reasons for doing so below.

Merz Aesthetics adheres to applicable local and regional privacy laws in the countries where we do business. We process your personal information in adherence with the local legal provisions applicable to the respective Merz Aesthetics company/entity. In the event any of the provisions in this Privacy Policy are inconsistent with the local legal provisions applicable to the respective Merz Aesthetics company/entity, such local legal provisions will prevail to the extent of the inconsistency.

Types of Information We Collect About You

Personal information is information or data about an individual who can be identified (a) from that data; or (b) from that data and other information to which Merz Aesthetics has or is likely to have access. Merz Aesthetics collects the following types of information and/or personal information:

Sources of Personal Information

- To, if necessary, prosecute or defend a legal claim

Sharing Your Personal information

Merz Aesthetics does not sell, trade, or rent data to third-party organizations. Merz Aesthetics will share your personal information with third-party organizations with which we partner to provide you with Merz Aesthetics products and services, and as described in the table provided below. Merz Aesthetics may share personal information with third parties to help manage our business and provide goods and services to our customers. Merz Aesthetics may use service providers to host, maintain, and operate the websites, manage social media profiles, send communications, conduct research, manage, and analyze data. If we share your personal information with third-party service providers, we do not authorize them to use or disclose it for any purpose other than the intended purpose.

Cookie Technology

Cookies are small text files that are stored on your computer or server that exchange settings-related information with Merz Aesthetics' systems. A cookie normally contains the name of the domain from which the cookie data were sent, information about the cookie's age, and an alphanumeric identifier. This Site uses aggregate cookie data to analyze and improve our website's relevance and your user experience.

Cookies are used to collect information about how you navigate our Site and what specific areas and products interest you. The information stored in the cookies is neither used to identify you nor is it combined with other stored personal information about you.

You can deactivate or restrict the transmission of cookies or delete any cookies already stored. If you choose to deactivate or delete cookies for the Merz Aesthetics websites, you may not be able to make full use of all the Site's functions.

Online Advertising to Promote Our Products

Merz Aesthetics uses third-party vendor remarketing tracking tools, including Facebook Pixel, to serve ads about Merz Aesthetics products online. These ads appear on Facebook, Google products, and on sites across the Internet.
